

### **Halifax 10k - Terms and Conditions**

1. Halifax Harriers reserve the right to cancel the Entrant's participation in the Event if any information provided by the Entrant is found to be inaccurate in any way.
2. The Entrant, by providing their details, applying and paying their Entry Fee is agreeing to enter the Event and agreeing to abide by these Terms and Conditions of Entry and subsequently the UKA Rules and Regulations and any instruction given to you by a Halifax Harriers official or UKA official.
3. All Entrants under the age of 18 (eighteen) years must obtain parental consent in order to register and participate in the Event.
4. The Entrant shall be deemed to have made themselves familiar with and agreed to be bound by the UKA Anti-Doping Rules and to submit to the authority of UK Anti-Doping in the application and enforcement of the Anti-Doping Rules.
5. It is the responsibility of the Entrant to ensure they are aware of all information relating to the Event.
6. For Entrants (including those under the age of 18), the Entrant's parent/guardian agrees that, as far as they are aware, the Entrant is physically able to compete in the Event and, to the extent that it may be necessary, they have sought and relied upon any medical advice before the date of the Event. Should any medical or physical condition arise prior to the Event which is likely to affect the Entrant's ability to compete in the Event, the Entrant should withdraw from the Event. The Entrant's parent/guardian (where applicable), consents to any medical treatment being administered to the Entrant during the Event by official medically-qualified personnel.
7. The Entrant understands and agrees that during the Event they will obey Marshals and Officials, instructions.
8. The Entrant confirms that they have completed sufficient training to ensure that they are fit enough to cope with the demands and stresses of the Event entered and that by entering the Event they are confirming that they are capable of completing the Event and that the organisers will not be held responsible for any injury or illness as a result of their participation.
9. The Entrant understands that in the event of any illness/accident during these activities, the Entrant gives FULL consent to any necessary medical treatment being administered, including anaesthetics if required.
10. The Entrant authorises the use of their name, voice, picture and video along with any information provided on the Event entry system/ form to be used without payment in any broadcast, telecast, communication, promotion, or advertising. The Entrant also agrees that the information provided may be

used by the Event organisers for the purpose of promoting future or other events or for the promotion of the event 's charity(ies), race sponsors, products and services.

11. The Entrant accepts that the Event Organiser cannot be liable to the fullest extent permitted by law, for any personal injury sustained by the Entrant in any way, or loss or damage to any personal property as a result of their participation in the Event.
12. The Entrant accepts that personal possessions left unattended at the venue in any facilities provided or otherwise are left entirely at the Entrant's own risk.
13. Halifax Harriers are not responsible for any third party organisations that may provide other services at the Event. The Entrant uses any such services at their own risk.
14. The Entrant must not allow any other person to wear the Event number.
15. The Entrant is not permitted to use any artificial aid or wheeled device, any pets or animals; or any other item that could potentially inhibit the flow or safety of other participants.
16. The Entrant must arrive at the start location at the specified time or may be refused permission to join the event.
17. The Entrant must complete the Event in line with timelines set by Event officials. Competitors will only be eligible to feature in the results if they complete the course before the official cut off time.
18. Halifax Harriers accepts no responsibility for the non-delivery of race numbers. A race number will be posted to the Entrant prior to the Event to the address provided upon completing of the entry form. If the Entrant does not receive their race number prior to the Event, it is their responsibility to contact **Time My Race** and a new number will only be available for collection on the day of the Event.
19. The Entrant should notify **Time My Race** of any change of address or contact details after entering the Event.
20. Transfer of race numbers is permitted only up to the advertised closing date.
21. Halifax Harriers will use their reasonable endeavours to provide the Entrant with a finish time in relation to the Event but shall not be responsible for any anomaly or technical malfunction in relation to the same.

22. Halifax Harriers are under no obligation to hold the Event and may cancel the Event for any reason.
23. If the Event is cancelled, Halifax Harriers shall not be liable for any losses incurred by an Entrant as a result of such cancellation.
24. Halifax Harriers and the Officials reserve the right to cancel the Event due to any "Force Majeure Event" which has a major impact on the Event taking place.
25. For the purposes of these Terms and Conditions, a "Force Majeure Event" means an event beyond the reasonable control of Halifax Harriers, including but not limited to: strikes, lock-outs or other industrial disputes (whether involving Halifax Harriers or others), failure of a utility service or transport network, act of God, war, riot, civil commotion, malicious damage, compliance with any law or governmental order, rule, regulation, direction or action by a government or public authority, accident, breakdown of plant or machinery, fire, inclement weather, flood, storm, communicable disease, national mourning, nuclear risks and chemical and biological weapons, act of terrorism, demonstration, march, request of an authoritative body such as the police or fire service, any order of repatriation, internment, imprisonment, deportation or the refusal of permit to enter any country where the event is to be held, seepage and/or pollution and/or contamination or default of Halifax Harriers or subcontractors.
26. If, as a result of a "Force Majeure Event", Halifax Harriers deems in its sole discretion that it is necessary to cancel, postpone or change the route and/or length of the Event, even during the period of the Event occurring, Halifax Harriers shall be entitled to cancel, postpone or change the Event.
27. If, as a result of a "Force Majeure Event," the Event is cancelled or postponed, the Entrant will not be offered a refund.
28. Halifax Harriers reserve the right to change the Event course or make any other amendment to the Event that is deemed necessary to stage the Event. Any material change to the Event will be communicated to the Entrant at the Event, or sooner if practicable.
29. Should the Event course distance be changed or reduced the Entrant agrees that the Event is still deemed to be staged and that Halifax Harriers will not be liable to the Entrant for any refund.

30. Nothing in these Terms and Conditions shall limit or exclude Halifax Harriers' liability in respect of death or personal injury resulting from its negligence, fraud or fraudulent misrepresentation, or any other liability that cannot be excluded or limited by law.
31. The Entrant agrees to indemnify Halifax Harriers in relation to any claims, action, liabilities or losses resulting from any breach of these conditions by the Entrant.
32. Halifax Harriers will not be liable for any pledges made by the Entrant or on his or her behalf to any charity.
33. Halifax Harriers may vary these Terms and Conditions from time to time and the up-to-date Terms shall be available on the Website.
34. Halifax Harriers accept no liability for the state or condition of the surface upon which the Event is held and the Entrant should ensure that they is satisfied with the state and condition of the surface of the route before commencing the Event.
35. For those Entrants who are aided around the course, either by being pushed or assisted, or guided by a guide runner, the guide runner must also be a registered participant in the Event. The Entrant requiring assistance must advise Halifax Harriers that they require assistance upon entry of their application and a free entry place will be provided to the guide runner.
36. It is strongly recommended that only experienced wheelchair racers attempt the Event unaided. Please note that it is the Entrant's responsibility to ensure that the Entrant's wheelchair is well maintained and suitable for such an event and no liability will be accepted by Halifax Harriers in respect of any damage occasioned to the Entrant's wheelchair howsoever occasioned during the Event. Halifax Harriers request the Entrant respects other participants in the Event and that the Entrant operate their wheelchair in a manner so as to avoid contact with or injury to any other participant, spectator or third-party including property belonging to third parties. The Entrant should ensure that they have in place appropriate public liability insurance which includes the use of the wheelchair in the participation of such Events.
